

# 4. PRICES

**STUDENTS** 

Rates are **per person**, per month, for a period of 11 months and include, **in addition to the room rental, as well as** the residential spaces and services indicated in item 3.

The fees indicated refer to the majority of room types in the facility. Possible variations in fees could depend on the characteristics of the room (exclusive use of the bathroom, size, etc...)





The relationship between Camplus and each admitted guest will be regulated by a special contract and will allow to take advantage of tax deductions in accordance with current regulations (Art. 1, paragraph 208, Law No. 244 of 2007 - Finanziaria 2008) and thus obtain a benefit of up to approximately 500 euros.

## 7. TRUTHFULNESS OF STATEMENTS

The declarant is responsible for the declarations made and forfeits the benefits obtained if it emerges that the truthfulness of the contents of the declarations. Untruthful statements are punishable under the Penal Code and of the relevant special laws (Art. 75 and 76 Presidential Decree No. 445 of December 28, 2000). Camplus, in turn, will perform a check at random on the declarations produced by the means at its disposal, reserving, where necessary, the right to request additional documentation.
