3.1 COST REDUCTIONS

As part of its institutional aims of promoting social integration and cultural education among young university students, the Nuovo Mondo cooperative provides annual support for deserving students and/or those lacking financial means. This support is provided both through the stipulation of agreements for the allocation of places to the local authorities responsible **for the right to education** and through the provision of additional fee reductions, at the discretion of the Cooperative's Board of Directors.

More specifically, the Nuovo Mondo cooperative offers students **4 income-based fee reductions**. Those who meet the requirements listed below may request these reductions **by April 7th 2026**.

Requirements to access the reduction based on Income:

- ◆ I.S.E.E (eligible for university entitlement benefits): Up to Euro 28,000¹
- ◆ Maintenance of requirements for renewal (from the 2nd year in Camplus);
- ◆ Sign a 12-month contract with Camplus for the 2026-2027 academic year.



The Cooperative will assign the income-based fee reductions **by April 15th 2026**. Reductions will be assigned in ascending order of I.S.E.E. In the case of equal ISEE scores, priority will be given to the candidate who has been staying at the Camplus Residence for the longest time; in the case of continued parity, priority will be given to the candidate who is youngest and, in the case of further parity, priority will be given to the Application with the earliest submission date.

¹I.S.E.E. certification is issued on the basis of the Single Substitutive Declaration that must be filled in and delivered to a Tax Assistance Centre (CAF) or to the INPS office responsible for the territory or municipality of residence. With regard to I.S.E.E. certification, it is specified that both the income and the movable and immovable property data refer to the year 2024 (Italian Decree Law 101 of 03/09/2019).

It should be noted that **it is the responsibility of the interested party to obtain the I.S.E.E. Certificate with the relevant protocol number** (e.g. INPS I.S.E.E. 2026-XXXXXXXX-00) and the note **"Applies to subsidised services for the right to university education"**, in good time for the deadlines for submitting the application. I.S.E.E. certificates with annotations regarding omissions and/or discrepancies found following the INPS (Italian National Social Security Institute) inspection will not be accepted. The student must present the I.S.E.E. certificate and the related DSU that have been corrected following any anomalies found.

5. CONTRACT

The relationship between Camplus and each admitted guest will be regulated by a special contract and will allow to take advantage of tax deductions in accordance with current regulations (Art. 1, paragraph 208, Law No. 244 of 2007 - Finanziaria 2008) and thus obtain a benefit. At the time of the signing of the contract, a security deposit and a membership fee to join the Camplus Network will be required.

6. TRUTHFULNESS OF STATEMENTS

The declarant is responsible for the declarations made and forfeits the benefits obtained if it emerges that the truthfulness of the contents of the declarations. Untruthful statements are punishable under the Penal Code and of the relevant special laws (Art. 75 and 76 Presidential Decree No. 445 of December 28, 2000). Camplus, in turn, will perform a check at random on the declarations produced by the means at its disposal, reserving, where necessary, the right to request additional documentation.
