Camplus Pavia Cravino Residence



Accommodation places at subsidized rates for students
enrolled in university degree courses, master's programs,
PhDs, and postgraduate specialization courses.

Fondazione Camplus, partner of Camplus, acting as concessionaire and in collaboration with the University of Pavia, within the framework of the three-year intervention program of the Lombardy Region, is making 129 accommodation places available at the Camplus Pavia Cravino Residence, located at **Via Cascinazza 15, Pavia**.

N. 129 places available, to be assigned primarily to students enrolled in university degree courses, master's programs, PhDs, and postgraduate specialization courses, however named.

2. PRICES

The Residence has a different price based on the type of the assigned room type. Prices are intended **per person** and include, in addition to the bed assignment, access to all residential spaces and services referred to in Section 1 of this Notice. The prices indicated below refer to a **12-month** period.

Fees for Resident Students: for all students who wish to renew their accommodation and meet the requirements set out in Article 3, the monthly fee for A.Y. 2026–2027 will remain the same as the fee paid during A.Y. 2025–2026, upon submission of the contract certifying such condition.

3. ADMISSION REQUIREMENTS

This Notice is addressed to students enrolled, or intending to enroll by 31 October 2026, in university and postgraduate courses. Applicants must meet the following requirements:

- ◆ Residence in a municipality located at least 30 km from the city of Pavia
- ◆ ISEE income indicator not exceeding €44,000, including the household of origin
- ◆ Possession of a student identification number (matriculation number) or a document certifying enrollment at the relevant Italian university, or declaration during the application phase of the intention to enroll by 31 October 2026
- ◆ No criminal convictions and no pending criminal proceedings
- ◆ No medical conditions incompatible with communal living

Failure to meet even one of the above requirements will result in exclusion from the selection process.

Note: For **international mobility students** (Erasmus, Overseas, etc.), the deadline of 31 October 2026 may vary depending on the university and the duration of the student's stay.

4. REQUIRED DOCUMENTATION

Applicants wishing to access the Residence must apply to Fondazione Camplus, manager of the property, by self-certifying the following information:

- ◆ Personal data
- ◆ Tax code
- ◆ Enrollment in a university course
- ◆ All elements necessary to determine the ISEE indicator suitable for university right-to-study benefits
- ◆ Distance between the municipality or district of residence and the municipality where the academic course takes place

5. APPLICATION FOR ASSIGNMENT

For new students, the application must be submitted by completing the dedicated online form available on camplus.it website under the link "[New Assignment Application](#)".

Students wishing to renew their place for Academic Year 2026–2027 under the same conditions applied in A.Y. 2025–2026 must complete the form they will receive by email within 15 days from receipt. The form will be sent by May 27, and therefore it cannot be returned after **June 10 2026**.

Failure to complete the form within the indicated deadlines will result in the loss of the right of pre-emption and the possibility to renew the accommodation under the same conditions. In such a case, the student must apply as a new applicant, without guarantee of accommodation assignment.

5.1 DURATION OF THE ASSIGNMENT

The allocations will formally expire on 30 April 2027.

In order to guarantee the inalienable right to education and the continuation of academic studies for the entire reference year, including through the continuity of accommodation services for residents, the University of Pavia guarantees that they may remain in the accommodation until 31 August 2027, under the same financial, regulatory and contractual conditions set out in this Call for Applications.

Allocation until 31 August 2027 will be guaranteed regardless of any changes in the residence's managing organisation and/or any technical extension measures that may be implemented, without this entailing any further obligations and/or additional financial burdens for the assignee.

6. RANKING

Accommodation places will be assigned according to the following procedures:

The first is governed by the agreement signed with the Lombardy Region on 13 April 2007, which allows students who were already residing in the accommodation during the previous academic year to renew their accommodation on a priority basis, provided they continue to meet the requirements set out in Article 3 above.

The **second** procedure applies to all new residents who, subject to the requirements set out in Article 3 above, will be allocated accommodation on a first-come, first-served basis, depending on the date of receipt of their applications, until all available beds are filled

Application for allocation when places are no longer available

Eligible students who have completed the application for allocation at a time when places in the Residence are no longer available will nevertheless be placed on a waiting list and contacted should places become available again.

7. CONTRACT

The relationship between Fondazione Camplus and each assigned student will be governed by a specific contract (the "Contract"); the Contract must be signed according to the deadlines and procedures indicated by the Camplus Management, under penalty of exclusion.

The Contract may allow students to benefit from tax deductions provided by the Italian tax system, in accordance with the regulations in force

8. TRUTHFULNESS OF STUDENT DECLARATIONS

The person declaring the information is responsible for all declarations made. Any benefits obtained will be forfeited if the information declared is found to be false or untrue. Untruthful statements are punishable under the Italian Penal Code and relevant laws (Articles 75 and 76 of Italian Presidential Decree No. 445 of 28 December 2000). Camplus, using the means at its disposal, may carry out random checks on Student declarations, and may request additional documentation, where necessary.
