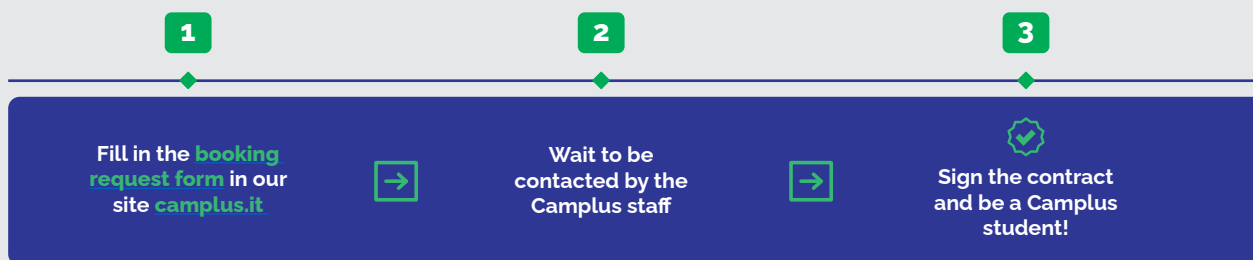

5. CONTRACT

6. TRUTHFULNESS OF STATEMENTS
